#### **New Business:**

Onsite Sewer Permit, 8 Old Cemetery Road - The City Sewer line is approximately a half mile from the parcel making a connection to costly. Council has requested that the sewer connection ordinance be attached to the deed of the land through Ferry County Professional Services. This will allow the future owners to know that if City Sewer main line is ever extended to the area and the current septic system fails, they will be required to connect to the City Sewer main line at that time.

**Motion:** Jim moved to approve 8 Old Cemetery Road installing a private sewer connection; Marty seconded. Motion passed unanimously.

Solid Waste Agreement with Ferry County - discussion was held on the 5-year agreement.
